A SUMMER holiday is more than just a break of routine; it's a chance to kick back, recharge and take a little time to dream.


If your dream includes trying out a lifestyle rather than a hotel room, a holiday home is an ideal vacation.

Qantas dodges mega lawsuit

A PASSENGER'S bid to sue Oantas for \$3.3 trillion has crashed and burned.

In a civil claim worth almost double the annual economic turnover of Australia, Sevmour Kern told the NSW Supreme Court he was not given "informed consent" before boarding a Qantas flight during which one of the plane's engines exploded.

The engine failure occurred during flight QF32 from SingaBEN PIKE

pore to Sydney on November 4, 2010. Nobody was physically injured during the incident and the plane returned safely to Changi Airport shortly after

Though he admitted he suffered no psychological or physical injuries, Mr Kern told the court Rolls Royce, Airbus and Qantas "knew about these faulty situations" but failed to

inform him when he bought his ticket.

Mr Kern demanded the three companies cover his personal expenses during the trial.

Justice Ian Harrison ruled that Mr Kern's initial claim for personal damages fell outside the two-year limitation period.

He also dismissed the rest of his case for being "not clear" and being directed at the wrong company. Mr Kern was ordered to pay legal costs.
